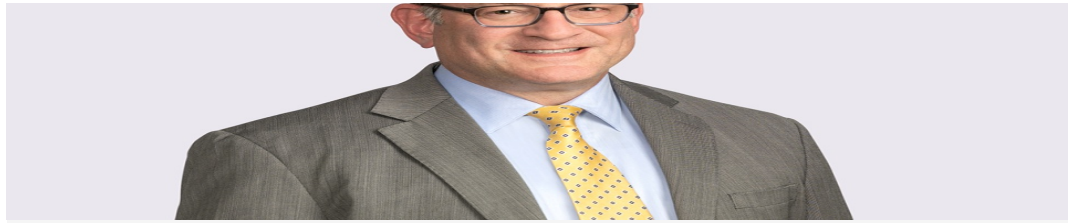
### The Year Ahead 2024: Healthcare

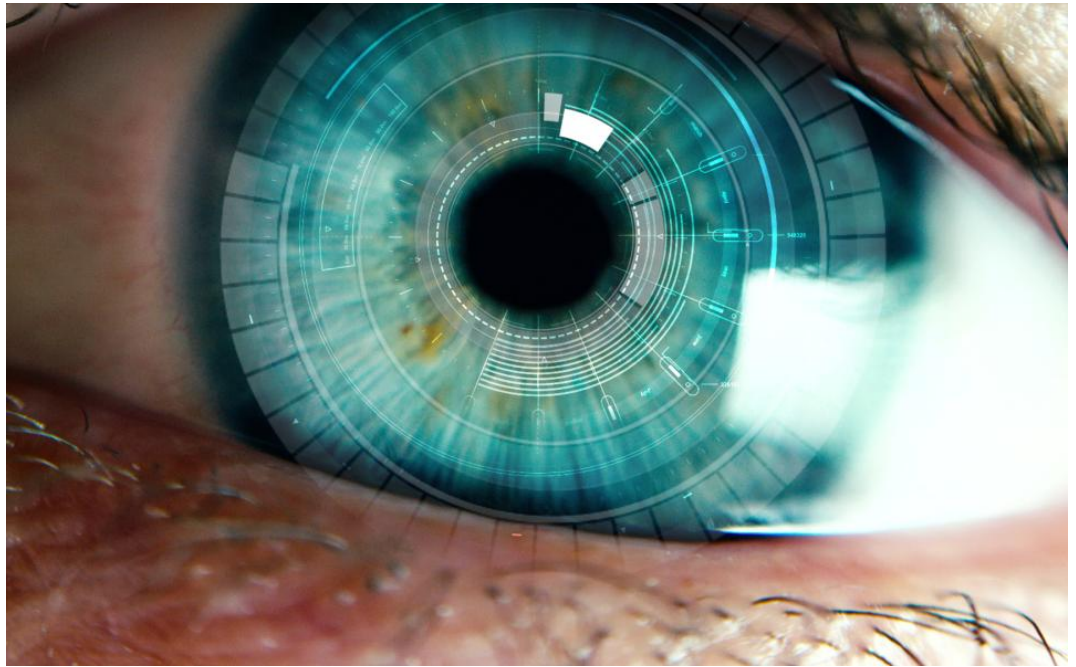

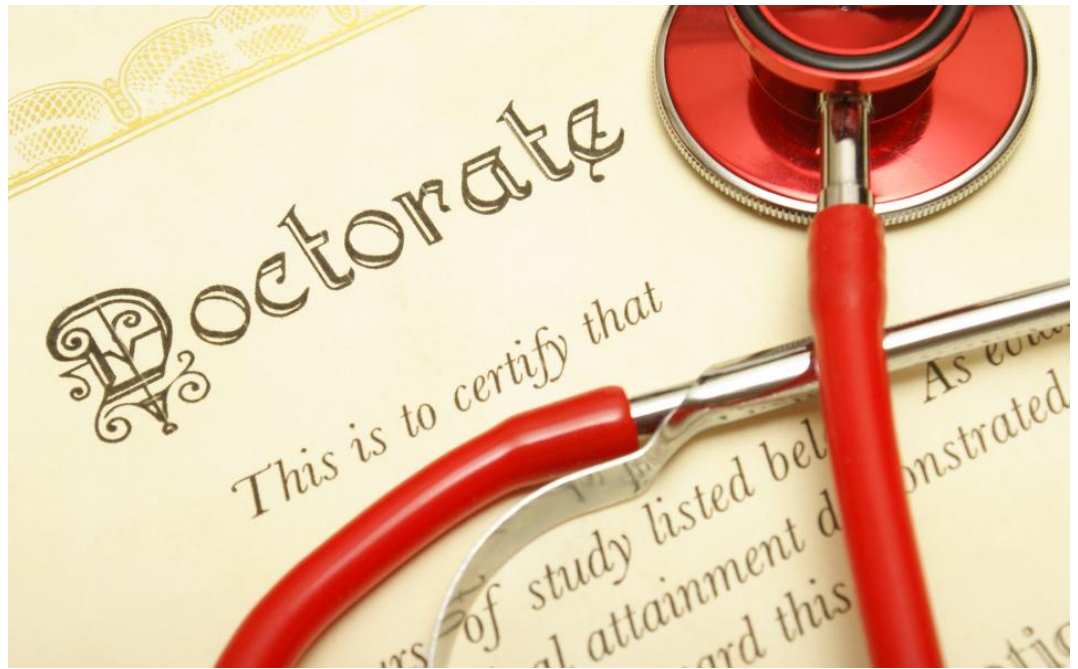
