He was also the Lead Task Force Attorney in charge of the District’s Organized Crime Drug Enforcement Task Forces (OCDETF) program, which is the centerpiece of the Department of Justice’s strategy to combat transnational organized crime and money-laundering threats.

Billy served as a law clerk to Judge Kent Jordan of the U.S. Court of Appeals for the Third Circuit and to Judge Eduardo Robreno of the U.S. District Court for the Eastern District of Pennsylvania.

Billy has taught Lawyering Skills as an adjunct professor of law at William & Mary Law School.
